XuanWu XW7301 resin is a modified polyphenylenether (mPPE) compound. XW7301 offers good performance on impact property, paintability, heat resistance, stiffness and chemical resistance.

## **Packaging and Drying**

Water contain of XuanWu will affect the molding process and the surface quality of end products. The moisture level of each XuanWu resin is controlled under 0.1% (1000 ppm) before packaging. The package types of XuanWu resins are shown in the following table. Special package can supplied upon request. Each package will be attached tag which shows the product grade, the lot number, the net weight. The products will be stacked on pallet. Maximum weight of each pallet is 1,000 kg.

(2) Polypropylene woven bag

The drying condition is recommended by 120°C for 4 hours. Insufficient drying will cause die drool, rough surface appearance, reduced output, and low mechanical properties. Streaks can be caused by overheating of the material (over 250 °C) or long time remaining in the barrel.

#### Storage

Please store XuanWu resins indoor with room temperature. Avoid to be in touched with water, oil or solvent. Some high purity grades of XuanWu must be stored under low dusty environment. The dust of package may cause contamination when it be opened.

Although XuanWu resins are thermoplastic polymer, long term storage is not recommended. The normal storage warranty will be 2 years.

#### **Product Safety**

For the safety properties of the material, we refer to our SDS which can be requested from our sales offices.


During practical operation we advise to wear personal safety protections for hand, eye, and body.

## Regrind

XuanWu resins are thermoplastic materials. Sprues, runners or side sheets are possible to be reprocessed. The regrinds must be clean, low thermally degraded and well dried. The acceptable level of regrind depends on the application. Be aware that regrind of purify grades is not recommended for original application.
